## 93.10 CONFIRMATION OF MINUTES OF PREVIOUS MEETINGS

#### 94.10 DECLARATIONS OF INTEREST

The Chairman reminded the Cllrs present of the need to declare any personal or prejudicial interests in respect of any items included on the Agenda. Cllr Chadney declared a prejudicial interest in the Planning DNPA 0246/10 as this is his home. Cllr Hardie declared a personal interest in the Post Inn as he lives opposite.

## 95.10 MATTERS ARISING

Superintendent Sharpe has written to state that she will not be attending a Drewsteignton Parish Council meeting but apologies for not inviting Drewsteignton Parish Council to the original meeting, however it is her intention to hold similar meetings twice a year giving Councillors the opportunity to meet her and local staff to discuss local issues. Cllrs requested that the Clerk write to Inspector Dave Hammond following the speed survey carried out at Crockernwell in April 2010 as there were a considerable amount of vehicles exceeding the speed limit. #### 97.10 PLANNING

00513/2010/OKE Mellish Martin Farm Whiddon Down. This application was to construct 2 mobile holiday units and associated parking. Cllrs decided to support this application as it was a good use of disused land and a useful update of derelict land. It is the policy of this parish council to support farm diversification in so far as possible. There will be negligible addition to traffic. Cllr Chadney informed us that according to DNPA there is a shortage of good quality short term accommodation this side of Dartmoor.

DNPA 0226/10 Land at Netherton, Drewsteignton. Erection of Agricultural Building 5.8m x 13.5m for storage. Cllrs decided to object to this application due to its size, location and isolation of the property.

DNPA 0233/10 Fairview Bungalow Drewsteignton. Replacement dwelling and garage with Studio above. Cllrs decided to support this application as it was tidying the area and was a replacement of an inhabitable property.

DNPA 0245/10 Smiths Cross Drewsteignton. Demolish Calf House and erect Livestock Building. Cllrs agreed to support this application as it is the policy of the Parish Council to support agriculture if possible.

DNPA 0246/10 1 Saddlers Close Crockernwell. Conversion of Garage attic space and extension. Cllr Chadney having declared a prejudicial interest left the room. Cllrs agreed to make no comment.
